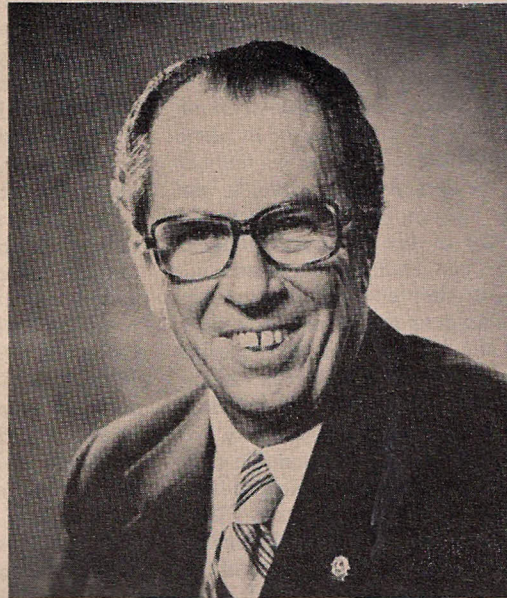




# Officers and Directors of Lions International
